Applications are invited in prescribed form available herewith in the official Website of the High Court of Tripura (<http://thc.nic.in>) from the eligible persons who are Indian citizens and who are not below 21 years of age and not more than 45 years in case of candidates belonging to Scheduled Castes & Scheduled Tribes and Govt. Servant and 40 years in case of others as on the date of Advertisement for filling up the following 4(four) posts of **System Officer** and 11(eleven) posts of **System Assistant** under e-Courts Services of the High Court of Tripura:
